

# Voter Suppression and Disenfranchisement: The Unseemly Corruption of the Hallmark of our Democracy

The goal of this class is to more thoroughly understand the long history of voter suppression and disenfranchisement, starting with the Constitution and now including subverting the U.S. Postal Service and a President who actively promotes other actions to reduce the vote.

## *Questions for Discussion*

- Using generalities, during our lifetime voter suppression and disenfranchisement have included the following: poll taxes and literacy tests (outlawed), partisan gerrymandering, voter ID laws, purging the rolls, closing down registration and voting sites, reducing times at registration and voting polls, intimidation, and now weaponizing the Postal Service, and the President openly opposing a fair and free vote. Flesh these out in more detailed efforts to reduce the vote.
- What do you see as the worst of these anti-democratic measures and why?
- Share what you’ve learned or have already known about efforts by individual states to negatively affect voting.
- What are steps we can take as a Church to fight for fair and free elections?

Our mission is to send 10 million of these letters to voters in key states in October. Handwritten letters to voters have significantly increased voter turnout in multiple experiments.
