# **Doctrine of Discovery: The Presbyterians**

This week Esther Milnes will lead us as we will take another look at the Doctrines of Discovery and how these doctrines are associated with the Presbyterians. Esther will share with us her research on the Presbyterians in the New Mexico Territory through the Board of Foreign Missions and the Board of Domestic Missions. Then she will update us on the actions of the PC(USA) General Assembly in 2016, 2018, and 2020, and the responses to these actions at the national, synod, and presbytery levels. We will discuss how our congregation might respond.

This class is a direct outcome of our action circle entitled, Asking for Grace. That circle is researching the history of our land, reviewing the actions and statements by the PC(USA), and will propose appropriate responses for our congregation.

#### Goal

To learn how Presbyterians were associate with the Doctrines of Discovery and what appropriate next actions we might take in addressing the harm done by these doctrines.
