Covid-19 Compliance and Refunds

FPC is following New Mexico Department of Health orders regarding the Covid-19 Pandemic which are based on Centers for Disease Control and Prevention guidance for halting the spread of Covid-19. The latest NMDOH Executive Order states: "All persons traveling into New Mexico from outside the state are ORDERED to wear a mask in public, self-isolate for 14 days (or for the duration of your stay if less than 14 days), and self-monitor for any symptoms".

While FPC anticipates these orders will be lifted or eased by late summer, there is no guarantee.

In the event FPC must cancel the Academy to comply with NMDOH orders, the registrant will be entitled to a 100% refund of any fees paid to FPC for the Academy. However, FPC will not be liable for any other costs or expenses the registrant has incurred. This includes travel, hotel, meals, and indirect, special, or consequential damages arising out of the registrant's inability to attend the Santa Fe Summer Organ Academy, even if FPC has been advised of the possibility of such damages.
